Comtec Solar 1Q2011 Revenue up approximately 60% Bottom Line up 311% with Strong Gross Profit Margin of 30.5%

Financial Review

Based on the preliminary review of the unaudited management accounts, the Company recorded a turnover of RMB317.9 million with the gross profit margin of 30.5% for 1Q2011. As a result, the profit attributable to the owners of the company was RMB83.5 million. The strong financial performance was mainly due to robust demand for our high quality wafers, an increase in our production capacity and higher selling prices for our wafers.

The Group continues to maintain a healthy balance sheet with net cash position of RMB72.1 million which includes cash and cash equivalents of RMB262.1 million and short-term bank loans of RMB190.0 million in 1Q2011.

"Following the outstanding results in 4Q2010, the Group continues to deliver excellent performance. Our experienced management and strong R&D team has continuously secured strong demand for our high quality wafers while we are able to keep production costs very competitive. This enables us to maintain strong profit margin With the strong market demand and our fast expanding capacity, we look forward to achieving excellent performance in 2011."
