During the three months ended 31 March 2013, the Group achieved 9.5% increase in revenue to RMB239.2 million. The Group’s gross profit during the period was RMB23.7 million with a positive gross margin of 9.9%. In addition, the Group recorded net profit of RMB10.6 million during the first quarter of 2013, turnaround from net losses of RMB159.7 million in the corresponding period last year.
